

(New) lifetime member Joseph Richards III has helped the Tamayos cut the grass a number of times over the year. In October, he also donated a pickup truck full of topsoil, as well as his entire day to help spread it, filling up many of the sunken areas throughout the cemetery. A Tenleytown neighbor, Melissa Kunstadter, has also helped out a number of times, weeding the front of the cemetery both last year and this year; she also helped Joe Richards and the Tamayos spread the truckload of dirt. We are lucky to have these industrious friends of the cemetery! Grass cutting expenses were kept to a minimum: We paid only \$245 to a landscaper!
